Wireless Communication Device Policy

For K–8 Students

Effective Date:

Adopted by: Emereau Bladen Charter School

Pursuant to N.C. Gen. Stat. § 115C-407.33 (HB 959, 2025)

1. Purpose

This policy ensures the responsible and developmentally appropriate use of wireless communication devices (WCDs), including cell phones, smartwatches, and similar personal technology, in accordance with North Carolina House Bill 959. The goal is to promote focused learning environments, student safety, and digital well-being.

2. Policy Summary

Grade Level	Policy During Instructional Time	Exceptions
K–8	Devices must be powered off and turned in during class time.	With staff permission for health, IEP/504 plan, or teacher-led academic use.

3. Prohibited Uses (All Grades)

Students may **not** use wireless devices:

- During instructional time for personal texting, calling, or social media.
- To access TikTok or any similar platform (per HB 959 ban).
- To record others without permission.
- To engage in cyberbullying, harassment, or academic dishonesty.
- To bypass school filters or access inappropriate content.

4. **Approved Use (When Permitted)**

When authorized by staff, student use may include:

- Accessing digital curriculum under teacher direction.
- Communicating with a parent/guardian in a **designated area** (e.g., front office).
- Health-related uses (e.g., blood glucose monitoring apps), as documented in student health plans.

5. **Consequences for Misuse**

Offense	Consequence
1st	Verbal reminder; device returned at end of day
2nd	Confiscation; parent/guardian must retrieve device

3rd+ Disciplinary referral; loss of device privilege; possible behavior plan update

Any illegal or threatening behavior will be referred to the administration and, if needed, law enforcement.

6. Storage & Signage

- Teachers will designate **secure storage** or require that devices stay in backpacks.
 - Clear signage will be posted in classrooms and hallways:
“**Learning Time = Device-Free Time**”

7. Parent & Student Agreement

All families must sign the **Wireless Communication Policy Agreement** annually. The policy will be reviewed with students during the first week of school and revisited quarterly.

8. Policy Review

This policy will be reviewed annually to:

- Evaluate effectiveness in reducing distractions and improving academic focus.
- Incorporate updates from state law and best practices in digital citizenship.
